

**NATIONAL COMEDY CENTER D.C. TRAVEL AND ADVENTURE SHOW
SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited by law and outside the United States. Subject to all federal, state, and local laws, regulations, and ordinances. The National Comedy Center Washington D.C. Travel & Adventure Show Sweepstakes (the “**Sweepstakes**”) begins on March 29, 2025, at 12:00:01 a.m. Eastern Time (“**ET**”) and ends on March 30, 2025, at 11:59:00 p.m. ET (the “**Sweepstakes Period**”). Sponsor’s computer is the official time keeping device for this Sweepstakes. **Any Prize Winners must be able to travel to Jamestown, NY to take receipt of and use the Prize.**

ELIGIBILITY: The Sweepstakes is open to legal U.S. residents currently residing in the 48 contiguous United States including the District of Columbia who are at least eighteen (18) years of age (nineteen (19) in AL or NE) or older as of the date of entry. Travel & Adventure Show, and scan the QR code for the Sweepstakes link located at the National Comedy Center booth, or, go directly to comedycenter.org/DCTravelShow. Then, complete and submit the Sweepstakes entry form along with all required information, including a valid home address, name, email address, and any other information that the form requests. Upon successfully submitting an entry form, you will be entered with one (1) entry into this Sweepstakes. By providing your email address, you agree to be added to the National Comedy Center Mailing List, to receive periodic updates and emails regarding the National Comedy Center, the Lucy Desi Museum, their respective retail stores, special offers and promotions. You may opt out of receiving these emails at any time, by either checking the “opt out” box on the entry form, or by following the link to unsubscribe contained within any received email.

Limit one (1) entry per person/email address. Upon submission of entry in this Sweepstakes, you agree that Sponsor may contact you via the contact information provided at the time of entry. You must provide all required information to be eligible to enter and win. All potential

winners are subject to verification before any prize will be awarded. **If you are entering via a mobile device and using your wireless carrier's network, standard data charges from your wireless carrier may apply.**

Entries must be submitted by the participant. No copies, facsimiles, or mechanical reproductions of the entry form will be accepted. Chautauqua Harbor Hotel stay subject to blackout dates. One (1) \$50 gift card for use at the National Comedy Center and Lucille Ball Desi Arnaz Museum in Jamestown, NY. Gift cards may be used to purchase admission to the National Comedy Center or Lucy Desi Museum, purchasing membership or event tickets sold through the National Comedy Center or Lucy Desi Museum, including tickets to Lucille Ball Comedy Festival events, food and beverage purchase at both museums and retail purchases at The Comedy Shop or Lucy Desi Museum Official Store (in-store only.) Prize winners must be able to travel to Jamestown, NY, on or before 12/30/2025 to claim and use the prize. Total Retail Value (“ARV”) of all prizes to be awarded: \$600.00. Limit one (1) prize per person and per household.
